ORDINANCE
AUTHORIZING THE PAYMENT OF PER DIEMS TO THE
SERGEANT-AT-ARMS OF THE CITY COUNCIL AND HIS
FOUR (4) DEPUTY SERGEANT-AT-ARMS AT THREE
HUNDRED PESOS (P300.00) AND AT ONE HUNDRED
PESOS (P100.00) EACH PER SESSION, RESPECTIVELY,
AND APPROPRIATING THE SUM OF SIXTY FOUR THOU-
SAND EIGHT HUNDRED PESOS (P64,800.00) FOR THE
PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF
QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The payment of per diems to the
Sergeant-at-Arms of the City Council, Capt. Elmo
San Diego and to his four (4) Deputy Sergeant-at-
Arms, Sgt. Artemio Hipolito, Cpl. Cecilio Marcelo,
Pfc. Walfredo Olabre and Pfc. Henry Mancucang, all
members of the Quezon City Police Force is hereby
authorized at Three Hundred Pesos (P300.00) and
at One Hundred Pesos (P100.00) each per session,
respectively, for a maximum of eight (8) paid
sessions actually attended per month.

SECTION 2. There is hereby appropriated from
any available funds in the City Treasury the sum
of Sixty Four Thousand Eight Hundred Pesos
(P64,800.00) or so much thereof as may be necessary
