ORDINANCE

GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE MRS. ERLINDA ASTURIAS (ALICIA VERGEL) WHO DIED DURING HER INCUMBENCY AS BARANGAY CAPTAIN OF BARANGAY STO. DOMINGO, QUEZON CITY ON MAY 20, 1992 AND TO THE FAMILY OF THE LATE MR. VICENTE COLINARES, FORMER BARANGAY CAPTAIN OF BARANGAY RAMON MAGSAYSAY, QUEZON CITY, IN THE AMOUNT OF ONE HUNDRED SEVENTY THREE THOUSAND NINE HUNDRED SEVENTY FIVE PESOS AND SIXTY ONE CENTAVOS (P173,975.61) AND SEVENTY THREE THOUSAND SIX HUNDRED FORTY SEVEN PESOS AND EIGHTEEN CENTAVOS (P73,647.18), RESPECTIVELY, IN ORDER TO ASSIST SAID FAMILIES IN SETTTLING THEIR RESPECTIVE MONETARY OBLIGATIONS WITH THE NATIONAL KIDNEY INSTITUTE FOR THE HOSPITALIZATION OF THE SAID BARANGAY OFFICIALS, TO BE TAKEN/CHARGED AGAINST THE SPECIAL PROJECTS FUNDS OF THE QUEZON CITY HEALTH DEPARTMENT OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT, SUBJECT TO THE AUDITING RULES AND REGULATIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. A Financial Assistance is hereby granted to the family of the late Mrs. Erlinda Asturias (Alicia Vergel) who died during her incumbency as Barangay Captain of Barangay Sto. Domingo, Quezon City on May 20, 1992 and to the family of the late Mr. Vicente Colinares, former Barangay Captain, Barangay Ramon Magsaysay, Quezon City, in the amount of One Hundred Seventy Three Thousand Nine Hundred Seventy Five Pesos and Sixty One Centavos (P173,975.61) and Seventy Three Thousand Six Hundred Forty Seven Pesos and Eighteen Centavos (P73,647.18), respectively, in order to assist the said families in settling their respective obligations with the National Kidney Institute for the hospitalization of the said barangay
