PROPOSED RESOLUTION NO. _____, S-2019

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO APCMVIC, INC., FOR THE CONSTRUCTION OF A PRIVATE MOTOR VEHICLE INSPECTION CENTER TO BE LOCATED AT 732 QUIRINO HIGHWAY, BARANGAY SAN BARTOLOME, DISTRICT-5, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, AS AMENDED, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, APCMVIC, INC., is a duly organized corporation and existing under Philippine Laws engage in the motor vehicles inspection represented by Mr. Patrick Leo Tan Chua, is applying for a Certificate of Exception for the construction of a private motor vehicle inspection center to be located at 732 Quirino Highway, Barangay San Bartolome, Quezon City;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, SP-2016, an Exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization from the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community


WHEREAS, the Sangguniang Barangay and the homeowners concerned have interposed no objection to the said project;

NOW, THEREFORE,


