BILO, WITH BUSINESS ADDRESS AT GLOBAL TRADE CENTER, 1024 EDSA, MUÑOZ RAMON MAGSAYSAY, QUEZON CITY TO OPERATE BUSINESS PROCESS OUTSOURCING, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE ECONOMIC ZONE AUTHORITY (PEZA), DEPARTMENT OF TRADE AND INDUSTRY (DTI), SECURITIES AND EXCHANGE COMMISSION (SEC) AND BUREAU OF INTERNAL REVENUE (BIR)**

**WHEREAS, TIMES SQUARE PREMIERE MANAGEMENT GROUP LIMITED**, represented by Ms. Lea P. Bilo, with Business address at Global Trade Center, 1024 EDSA, Muñoz, Ramon Magsaysay, Quezon City to operate business process outsourcing, subject to the rules and regulations promulgated by the Philippines Economic Zone Authority (PEZA), Department of Trade and Industry (DTI), Securities and Exchange Commission (SEC) and Bureau of Internal Revenue (BIR);

**WHEREAS**, to enable the applicant to operate the aforesaid Business Process Outsourcing, there is a need to secure a Special Permit from the City Council pursuant to an existing city ordinance;

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant or renew a special permit to business activity of the same nature.

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED**, to grant, as it does hereby grant, a Special permit to **TIMES SQUARE PREMIERE MANAGEMENT GROUP LIMITED** represented by Ms. Lea P. Bilo, with Business address at Global Trade Center, 1024 EDSA, Muñoz, Ramon Magsaysay, Quezon City, subject to the Rules and Regulations promulgated by the Philippines Economic Zone Authority (PEZA), Department of Trade and Industry (DTI), Securities and Exchange Commission (SEC) and Bureau of Internal Revenue (BIR);


**RESOLVED FURTHER**, that the authority to operate Business Process Outsourcing granted herein shall be subject to the condition below:

- a. The holding of Business Process Outsourcing shall be in accordance with the Rules and Regulations promulgated by Philippines Economic Zone Authority (PEZA), Department of Trade and Industry (DTI), Securities and Exchange Commission (SEC) and Bureau of Internal Revenue (BIR);

**RESOLVED FINALLY**, that this renewal of Special Permit to operate a Bingo/Center/Hall shall be valid for a period of two (2) years from the approval of this Resolution and maybe renews again by the City Council.
