AN ORDINANCE AMENDING ORDINANCE NO. SP-2180, SERIES OF 2012. ENTITLED "AN ORDINANCE ENACTING THE QUEZON CITY CHILDREN'S CODE OF 2012".

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 3 of Ordinance No. SP-2180, S-2012 is hereby amended to include the following:

SECTION 2. Section 13 of Ordinance No. SP-2180, S-2012 is hereby amended to insert the following paragraph:

"The Quezon City Government shall promote child care and maternal health pursuant to Republic Act No. 11148 (Kalusugan at Nutrisyon ng Mag-Nanay Act) and Ordinance No. SP-2703, S-2018 (An Ordinance Institutionalizing an Early Childhood Development Intervention Package for the First One Thousand (1,000) Days of a Child)."

SECTION 3. Section 17 of Ordinance No. SP-2180, S-2012, is hereby amended to insert the following:

"The integrated health service for children with disabilities shall be pursuant to Ordinance No. SP-2617, S-2017 (An Ordinance Institutionalizing a Comprehensive Program for Children with Special Needs, Thereby Establishing a Center and Providing Funds Thereof and for Other Purposes), as amended by Ordinance No. SP-2718, S-2018."

SECTION 4. Section 51 of Ordinance No. SP-2180, S-2012 is hereby amended to read as follows:

"SECTION 51. CHILDREN'S MONTH CELEBRATION – The City shall celebrate the National Children's Month every November, pursuant to Republic Act No. 10661 (National Children's Month Act), by conducting child-focused activities promoting the rights and responsibilities of children."

SECTION 5. SEPARABILITY CLAUSE - If for any reason, any part, section or provision of this Ordinance shall be held invalid or unconstitutional, other provisions or parts thereof not affected thereby shall remain in full force and effect.
