ORDINANCE NO. SP- **2866**, S-2019

AN ORDINANCE ESTABLISHING A SENIOR HIGH SCHOOL LOCATED IN BARANGAY BAGONG SILANGAN, QUEZON CITY WHICH SHALL BE NAMED AFTER GENERAL LICERIO GERONIMO, THE HERO OF THE BATTLE OF SAN MATEO.

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that "The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all.";

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, the Local School Board (LSB) has recommended the establishment of a senior high school in Barangay Bagong Silangan.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. There is hereby established under the Quezon City Schools Division Office a Senior High School, located at Barangay Bagong Silangan, to be known as the General Licerio Geronimo Senior High School.

SECTION 2. The supplemental funds necessary for the construction, maintenance, and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.


SECTION 3. In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.


