ORDINANCE NO. SP- 2880 , S-2019

AN ORDINANCE ALLOWING ONE-SIDE PARKING SCHEME AND NO PARKING ON BOTH SIDES/TOW AWAY ZONE WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY PINYAHAN, QUEZON CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a)(5)(v) and (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the Powers, Duties, Functions of the Sangguniang Panlungsod:

- (v) Regulate the use of streets, avenues, alleys, sidewalk, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same, xxx.
- (vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, xxx.

WHEREAS, the Sangguniang Barangay of Barangay Pinyahan, District IV, Quezon City, passed Resolution No. 016, Series of 2019 entitled, "Barangay Council Resolution approving the one-side parking scheme and no parking on both sides/tow away zone within the territorial jurisdiction of Barangay Pinyahan, Quezon City";

WHEREAS, Barangay Pinyahan, Quezon City has several busy roads/streets in the area and is experiencing traffic congestion;

WHEREAS, the said problem has already been addressed during the conduct of general assembly held last March 16, 2016 and March 24, 2017, respectively and public consultation held on August 5, 2018;

WHEREAS, there is a need to prescribe a systematic, organized and fully implementable mechanism of maximizing the limited road space available to ensure the smooth and unhampered flow of traffic.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. - This Ordinance shall be known as the "One-Side Parking Scheme and No Parking on Both Sides/Tow Away Zone within the territorial jurisdiction of Barangay Pinyahan, Quezon City."

SECTION 2. COVERAGE. - It is hereby required to obey the one-side parking scheme and prohibits to park on both sides within the territorial jurisdiction of Barangay Pinyahan.

SECTION 3. THE NEW TRAFFIC SCHEME. -

SECTION 3. IMPLEMENTING RULES AND REGULATIONS – The Quezon City Transport and Traffic Management Department, Barangay Traffic Enforcer and Barangay Public Safety Officers of Barangay Pinyahan shall formulate and issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 4. PENALTIES. - All penalties, fines or surcharges shall be the same as those prescribed under Ordinance No. SP-2785, S-2018 for motor vehicle violations.

SECTION 5. REPEALING CLAUSE. - All ordinances, resolutions, executive orders, memorandum circulars and all other issuances or parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.
