ORDINANCE NO. SP- 2886, S-2019

AN ORDINANCE GRANTING ADDITIONAL INCENTIVE TO ALL PLANTILLA POSITION EMPLOYEES OF THE QUEZON CITY GOVERNMENT EQUIVALENT TO ONE (1) MONTH SALARY TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY.

WHEREAS, in 2018, the City granted additional incentive to employees of the Quezon City Government equivalent to one (1) month salary through Ordinance No. SP-2792, S-2018;

WHEREAS, with the sound financial management of the City, it is high time that the salaries of employees must be taken into consideration;

WHEREAS, due to the increase in the prices of basic commodities, the grant of additional incentive to all plantilla position employees of the Quezon City Government is imperative.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
