ORDINANCE NO. SP- 2897, S-2020

AN ORDINANCE IMPOSING ONE PESO (PHP1.00) INCREASE TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY COVERING THE PERIOD FROM MARCH 1 TO 31, 2020, THE PROCEEDS THEREOF TO BE DONATED TO THE ROTARY FOUNDATION OF ROTARY INTERNATIONAL DISTRICT 3780 TO SUPPORT ITS CAUSE-ORIENTED PROGRAMS AND ACTIVITIES.

WHEREAS, Rotary International District 3780, involves 100 Rotary Clubs in Quezon City which consists of over 2500 Rotarians providing humanitarian services in the communities of Quezon City;

WHEREAS, Rotary International District 3780 has numerous cost oriented programs and activities in Quezon City involving blood donations, provision for clean drinking water for various schools in Quezon City, Botika sa Barangay, disaster preparedness and assistance, programs on health, hunger and poverty alleviation, literacy and education, environmental protection, search for outstanding policemen, nutrition and many other laudable activities beneficial to the residents of Quezon City;

WHEREAS, in 2016, in recognition for its valuable programs and activities that have benefited numerous residents and communities in Quezon City, the 20th Quezon City Council enacted City Ordinance No. SP-2534, S-2016, imposing One Peso (Php1.00) increase to admission fees in all cinemas in Quezon City covering the period from November 1 to 30, 2016, the proceeds thereof to be donated to the Rotary Foundation of Rotary International District 3780 to support its civic programs and activities in recognition of the 100th Year of the Rotary Foundation;

WHEREAS, to show the unwavering support of the Quezon City Government to the Rotary International District 3780, the City again intends to increase the admission fees in all cinemas in Quezon City by One Peso (Php1.00), the proceeds of which shall be donated to the Rotary Foundation to support various civic organizations and to help finance its programs and activities that ultimately will also benefit the needy residents and communities of Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (Php1.00) from March 1 to 31, 2020.

SECTION 2. The proceeds of the admission fee increase as prescribed in Section 1 hereof shall be donated to the Rotary Foundation of Rotary International District 3780 to support its civic programs and activities.

SECTION 3. The Rotary Foundation of Rotary International District 3780 shall include in its Information Dissemination such as, but not limited to, press releases, marketing paraphernalia, flyers, among others, that the projects covered by the amount collected is made possible in partnership with the Quezon City Government.

SECTION 4. All cinemas shall remit directly within fifteen (15) days, after March 31, 2020, to the City Treasurer's Office (CTO) the amount collected under this Ordinance.
