ORDINANCE NO. SP- 2900 , S-2020

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. SP-115, S-93 PROVIDING PREFERENTIAL RIGHTS TO REGISTERED VOTERS AND BONAFIDE RESIDENTS OF THE BARANGAY WHEREIN INFRASTRUCTURE CONSTRUCTIONS AND BUSINESS ESTABLISHMENTS ARE LOCATED.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The fine of Php1,000.00 to Php2,000.00 provided for in Section 4 of Ordinance No. SP-115, S-93 is hereby amended to Five Thousand Pesos (Php5,000.00).

SECTION 3. SEPARABILITY CLAUSE. - In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall remain in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately after the publication requirements have been complied with.
