ORDINANCE No. 2909 S- 2020

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1, GENERAL FUND FOR FISCAL YEAR 2020, IN THE AMOUNT OF TWO BILLION AND EIGHT HUNDRED MILLION PESOS (PHP2,800,000,000.00), IN RESPONSE TO COVID-19 PANDEMIC AND FOR OTHER OPERATIONAL EXPENSES.

WHEREAS, the Local Chief Executive submitted to the Sangguniang Panlungsod, through the Office of the Secretary to the Sangguniang Panlungsod, the proposed Supplemental Budget of the City on April 8, 2020;

WHEREAS, the Local Government Code of 1991 provides that "on or before the end of the current fiscal year, the Sanggunian concerned shall enact through an ordinance, the annual budget of the local government unit for the ensuing fiscal year on the basis of the estimates of income and expenditures;

WHEREAS, there is an urgent need to pass this Ordinance to support the additional financial needs and expenditures of the City Government for the Fiscal Year 2020;

WHEREAS, it is imperative for the Sangguniang Panlungsod to approve Supplemental Budget No. 1, General Fund for Fiscal Year 2020, of Quezon City, in support of the City Government's programs and projects to suppress and control the spread of COVID-19, and to mitigate its effects and impact to the community.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Supplemental Budget No.1 of the Quezon City Government for Calendar Year 2020 is hereby Approved in the amount of TWO BILLION EIGHT HUNDRED MILLION PESOS (P2,800,000,000.00) covering the various expenditures for the operation of the City Government to suppress and control the spread of COVID-19, and to mitigate its effects and impact to the community for the following purposes

SECTION 3. SEPARABILITY CLAUSE - If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, all other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon its approval.
