AN ORDINANCE DECLARING EVERY LAST WEEK OF SEPTEMBER AS FAMILY WEEK IN QUEZON CITY AND PROVIDING FOR ITS ANNUAL OBSERVANCE AND FOR OTHER PURPOSES.

WHEREAS, Section 12, Article II of the Constitution of the Philippines provides that: "The State recognizes the sanctity of family life and shall protect and strengthen the family as a basic autonomous social institution;"

WHEREAS, Section 1, Article XV of the Constitution also provides that: "The State recognizes the Family as the foundation of the nation. Accordingly, it shall strengthen its solidarity and actively promote its total development";

WHEREAS, Article 149, Chapter V of the Family Code of the Philippines, provides that: "The family, being the foundation of the nation, is a basic social institution which public policy cherishes and protects. Consequently, family relations are governed by law and no custom, practice or agreement destructive of the family shall be recognized or given effect";

WHEREAS, Proclamation No. 60, Series of 1992 declares the last week of September of every year as Family Week;

WHEREAS, to give life to the mandate of the constitution and laws, there is a need to call public attention and ensure citywide awareness of the importance of the family.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. It is hereby declared the last week of September as "Family Week" and shall be observed and celebrated every year in Quezon City.

SECTION 2. The Office of the City Mayor will spearhead to designate the concerned office/s in observance of the said activity.
