AN ORDINANCE RENAMING THE CRUZ NA LIGAS ELEMENTARY SCHOOL TO KRUS NA LIGAS ELEMENTARY SCHOOL LOCATED AT BARANGAY KRUS NA LIGAS.

WHEREAS, the name "Cruz Na Ligas Elementary School" has been used since time immemorial and there has been some confusions and misconceptions as to the correct spelling of the name of the school;

WHEREAS, the Sangguniang Barangay of Barangay Krus na Ligas, through Resolution No. 111 Series of 2019, recommended the renaming of Cruz na Ligas Elementary to Krus na Ligas Elementary School.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:

SECTION 1. Cruz na Ligas Elementary School, located in Barangay Krus na Ligas, is hereby renamed under the Quezon City Schools Division Office as the "Krus Na Ligas Elementary School."


SECTION 2. The supplemental funds necessary for the construction, maintenance, and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.

SECTION 3. REPEALING CLAUSE. - All previous ordinances, rules and regulations, or parts thereof which are inconsistent with the foregoing are hereby modified, amended, or repealed accordingly.

SECTION 4. SEPARABILITY CLAUSE. - If any part of the provisions of this Ordinance is held unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to remain in full and effect.
