AN ORDINANCE RENAMING THE TANDANG SORA SENIOR HIGH SCHOOL TO MELCHORA AQUINO HIGH SCHOOL.

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that the "State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, Tandang Sora Senior High School, located at Denmark Street, Upper Banlat, Barangay Tandang Sora, Quezon City was established through Ordinance No. SP-2818, S-2019;

WHEREAS, the Quezon City Council enacted Ordinance No. SP-2920, S-2020 converting the Tandang Sora Senior High School to an integrated High School enabling the latter to accept junior and senior high school learners;

WHEREAS, given the existence of Tandang Sora National High School, there is a need to rename Tandang Sora Senior High School to avoid confusion;

WHEREAS, the Local School Board, through a resolution, recommended the renaming of Tandang Sora Senior High School to Melchora Aquino High School.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Tandang Sora Senior High School located at Denmark Street, Upper Banlat, Barangay Tandang Sora, Quezon City is hereby renamed to Melchora Aquino High School.

SECTION 2. The supplemental budget necessary for the maintenance and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.





SECTION 4. This Ordinance shall take effect immediately upon its approval.




