AN ORDINANCE ESTABLISHING THE QUEZON CITY DIALYSIS CENTER BY WAY OF RETROFITTING THE BUILDING OF AN EXISTING PORTION OF THE QUEZON CITY GENERAL HOSPITAL TO ACCOMMODATE MULTIPLE DIALYSIS MACHINES LOCATED IN DIFFERENT HEALTH CENTERS SUBJECT TO ALL LEGAL AND EXISTING FUNDS AND FOR OTHER PURPOSES.

WHEREAS, the 1987 Philippine Constitution provides that the State shall promote the right to public health of the people;

WHEREAS, under Section 16 (General Welfare Clause) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, local government units are mandated to ensure and support the promotion of health and safety, among other things, within their territorial jurisdiction;

WHEREAS, there is an existing facility within the premises of Quezon City General Hospital that can accommodate multiple dialysis machines which can be used as Quezon City Dialysis Center that can cater to kidney patients residing within Quezon City.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. ESTABLISHMENT. - It is hereby established a "Quezon City Dialysis Center" to be under the direct supervision of the Office of the City Mayor.

SECTION 2. APPROPRIATIONS. - The amount necessary to carry out the provisions of this Ordinance shall be included in the Annual Budget of Quezon City of the year following its enactment into law and every year thereafter.

SECTION 3. SEPARABILITY CLAUSE. - If any provision of this Ordinance is held invalid or unconstitutional, the other provisions not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.
