*AN ORDINANCE RE-CLASSIFYING AND CONVERTING THE TWO CLASSIFIED ROAD LOTS, DESIGNATED AS JOCSON PARK AND MELCHOR PARK, LOCATED INSIDE VARSITY HILLS SUBDIVISION, BARANGAY LOYOLA HEIGHTS, QUEZON CITY, INTO PARKS OR OPEN SPACES.*

*WHEREAS, Jocson Park and Melchor Park are located inside Varsity Hills Subdivision, Loyola Heights, Quezon City;*

*WHEREAS, the abovementioned parks, upon actual site inspection made by the Subdivision Administration Unit of the City Planning and Development Department, the lands are actually used as mini parks;*

*WHEREAS, based on the Property Identification Map of the City Assessor's Office both said parks are classified as road lots;*

*WHEREAS, the Local Government Code of 1991 provides that the local Sangguniang Panlungsod may, through an ordinance, reclassify a parcel of land for public purposes;*

*WHEREAS, to resolve the controversy, there is a need for a local legislative act to convert the identified road lots into actual parks or open spaces.*


