ORDINANCE NO. SP-**3023**, S-2021

AN ORDINANCE AMENDING ORDINANCE NO. SP-2854, S-2019, OTHERWISE KNOWN AS "THE QUEZON CITY PUBLIC VETERINARY CLINIC ORDINANCE" PROVIDING FOR A DEFINITION OF TERMS, UPDATING THE SCHEDULE OF FEES AND CHARGES AND INCLUDING THE CITY LEGAL DEPARTMENT AS PART OF THE IMPLEMENTING COMMITTEE.

WHEREAS, Ordinance No. SP-2854, S-2019, which provides for the establishment of Quezon City Public Veterinary Clinic, was enacted by the 20th City Council on June 17, 2019, and the same was approved by then City Mayor, Honorable Herbert M. Bautista on June 27, 2019;

WHEREAS, the Quezon City Public Veterinary Clinic Ordinance was established to give low-income pet owners access to affordable veterinary services, and to accord pets in Quezon City veterinary consultation, treatments, vaccination, grooming, medicines and animal supplies;

WHEREAS, there is a need to amend and update Ordinance No. SP-2854, S-2019 to fully realize its intent in the interest of veterinary public health.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There shall be a new Section 3.1 to be inserted in Ordinance No. SP-2854, S-2019, which shall be read as follows:

“SECTION 3.1 DEFINITION OF TERMS. - For purposes of this Ordinance, the following definitions are hereby adopted:

- a. *Animal Welfare - refers to the health and safety of animals.*
- b. *Anesthesia - refers to the state in which a patient is rendered insensible to all sensations either locally, as with local anesthetic, or completely as with general anesthetic.*
- c. *Anesthetic - refers to the agents which are used to render a patient insensible to all sensations either locally, as with local anesthetic, or completely as with general anesthetic.*
- d. *Animal Patient - refers to an animal accepted by veterinary clinics/hospitals for veterinary care and services.*
- e. *Licensed Veterinarian - refers to a person who graduated from an accredited Veterinary School with a degree of Doctor of Veterinary Medicine and duly registered at the Professional Regulation Commission.*
- f. *Surgery - refers to the procedure performed in the animal with the use of surgical instruments involving incision, excision, and/or transection of organs or part of it with the use of anesthetic.*

- g. *Treatment - refers to the management and care of sick animals with existing disorders by administering the proper medicine.*
- h. *Veterinary Clinic - refers to an establishment where veterinary medical cases are managed and handled by a duly licensed veterinarian with facilities for diagnosis and treatment of animal patient.*
- i. *Cremation - method of final disposition of a dead body through burning.*
- j. *Euthanasia - act of painlessly putting animals to death or allowing to die by withholding extreme medical measure.*
- k. *Microchips - an identifying integrated circuit placed under the skin of the animal.*
- l. *Spay and Neuter - Spaying is the removal of reproductive organs of female dogs and cats. Neutering is the removal of the testicles in male dogs and cats."*

SECTION 2. Section 4 on Schedule of Fees and Charges of the same Ordinance is hereby amended to read as follows:

"Section 4. SCHEDULE OF FEES AND CHARGES. – The Quezon City Public Veterinary Clinic is hereby authorized to collect fees for services rendered as follows:

SECTION 3. Section 5 of Ordinance No. SP-2854, S-2019 is hereby amended to add the City Legal Department as part of the Veterinary Clinic Implementing Committee.

SECTION 4. REPEALING CLAUSE. - All previous issuances, ordinances, rules and regulations or parts thereof which are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. - If, for any reason, any section or provision of this Ordinance is declared unconstitutional or invalid, the remaining sections or provisions hereof which are not affected thereby shall remain to be in full force and effect.


SECTION 6. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.


