ORDINANCE NO. SP- **3030**, S-2021

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1, GENERAL FUND FOR FISCAL YEAR 2021, IN THE AMOUNT OF SIX BILLION ONE HUNDRED THIRTY-ONE MILLION THREE HUNDRED THIRTY-THREE THOUSAND FIVE HUNDRED TWENTY-FIVE PESOS (PHP6,131,333,525.00) TO COVER THE VARIOUS EXPENDITURES OF THE QUEZON CITY GOVERNMENT.

*WHEREAS, Ordinance No. SP-2977, S-2020 was enacted by the City Council approving the Annual Budget of the Quezon City Government in the total amount of Twenty-Eight Billion Seven Hundred Million Pesos (Php28,700,000,000.00) to fund the various expenditures of the City Government for Fiscal Year 2021;*

*WHEREAS, there is a need to appropriate a Supplemental Budget in the amount of Six Billion One Hundred Thirty-One Million Three Hundred Thirty-Three Thousand Five Hundred Twenty-Five Pesos (Php6,131,333,525.00) to fund and complete the various programs and projects of the Quezon City Government;*

WHEREAS, the Local Finance Committee attests that the surplus amount of Six Billion One Hundred Thirty-One Million Three Hundred Thirty-Three Thousand Five Hundred Twenty-Five Pesos (Php6,131,333,525.00) is available in the coffers of the Quezon City Government to support the various public expenses;

WHEREAS, it is imperative for the Sangguniang Panlungsod to approve Supplemental Budget No. 1, General Fund for Fiscal Year 2021, of Quezon City, in order to support and to cover the expenses for the implementation of the various programs and projects of the City Government.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

**SECTION 1. APPROPRIATION.** - The amount of Six Billion One Hundred Thirty-One Million Three Hundred Thirty-Three Thousand Five Hundred Twenty-Five Pesos (Php6,131,333,525.00) is hereby appropriated as an integral part of the General Fund Budget for Fiscal Year 2021, by way of Supplemental Budget No. 1, to finance the implementation of various programs and projects, and operational expenditures of the Quezon City Government.

**SECTION 2. EXPENDITURES.** - The appropriated amount of Six Billion One Hundred Thirty-One Million Three Hundred Thirty-Three Thousand Five Hundred Twenty-Five Pesos (Php6,131,333,525.00) in accordance with the specific items of expenditures is hereby broken down as follows:

*SECTION 5. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.*

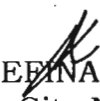
