ORDINANCE NO. SP- **3033**, S-2021

AN ORDINANCE AMENDING SECTION 11 OF ORDINANCE NO. SP-3019, S-2021, MANDATING THE FULL IMPLEMENTATION OF KYUSIPASS CONTACT TRACING METHOD THROUGH SAFEPASSS FOR ALL RESIDENTS AND NON-RESIDENTS, AND ESTABLISHMENTS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY, NOT LATER THAN AUGUST 15, 2021.

*WHEREAS, on 8 March 2020 President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency throughout the Philippines" because of the COVID-19 pandemic;*

*WHEREAS, in a Special Session held on March 13, 2020, the 21st City Council adopted Resolution No. 8141, S-2020, which declared Quezon City under a State of Calamity due to the pandemic;*

WHEREAS, on March 22, 2021, the Quezon City Council enacted the "KyusiPass Ordinance". The same was signed by the Honorable City Mayor, Ma. Josefina G. Belmonte on April 15, 2021. KyusiPass, is a contact tracing app powered by SafePass, as part of the health monitoring system of the city, to provide a contactless and more efficient contact tracing of COVID-19 activity within the city, in compliance with DILG Memorandum Circular No. 2020-007 and IATF Resolution No. 42 Series of 2020;

WHEREAS, Section 11 of Ordinance No. SP-3019, S-2021 provides for a six (6) months transition period before its full implementation;

WHEREAS, considering the reported cases of a more contagious and transmissible COVID-19 variant, e.g. Delta variant, also known as B.1.617.2, there is a need to fully implement the "KyusiPass Ordinance" a non-extendible period of not later than August 15, 2021.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 11 of Ordinance No. 3019, S-2021 is hereby amended to read as follows:

"Section 11. TRANSITION PERIOD - All establishments covered by Ordinance No. SP-3019, S-2021 shall prepare their QR Code scanner system, the full implementation thereof shall not be later than August 15, 2021."

SECTION 2. SEPARABILITY CLAUSE. - In case any provision, section, or part of this Ordinance is declared unconstitutional or illegal, the remaining provisions not affected thereby shall continue to be in full force and effect.

SECTION 3. REPEALING CLAUSE. - Section 11 of Ordinance No. SP-3019, S-2021 is hereby modified accordingly. All other existing Ordinances and Resolutions contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.


