ORDINANCE NO. SP- **3047**, S-2021

AN ORDINANCE AMENDING ARTICLE IV OF ORDINANCE NO. SP-2791, S-2018 WHICH PROVIDES FOR THE ORGANIZATION OF THE QUEZON CITY ANTI-DRUG ABUSE ADVISORY COUNCIL TO CORRESPOND WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) AND THE DANGEROUS DRUGS BOARD (DDB) JOINT MEMORANDUM CIRCULAR NO. 2018-01.

WHEREAS, on May 26, 2018 and June 23, 2018, the City Council and the City Mayor, enacted and approved, respectively, Ordinance No. SP-2791, S-2018, entitled:

"AN ORDINANCE PROVIDING FOR THE DANGEROUS DRUGS CODE OF QUEZON CITY"

WHEREAS, on May 21, 2018, the Department of the Interior and Local Government (DILG) and the Dangerous Drugs Board (DDB) issued a Joint Memorandum Circular No. 2018-01 with the subject: Implementing Guidelines on the functionality and effectiveness of Local Anti-Drug Abuse Councils;

WHEREAS, Item Number V, Letter C of the aforementioned Joint Memorandum Circular No. 2018-01, provides for the composition of the City's Anti-Drug Abuse Council (CADAC);

WHEREAS, there is a need to amend Ordinance No. SP-2791, S-2018, specifically Section 1, Article IV, which provides for the Anti-Drug Abuse Campaign Organization of the Quezon City Anti-Drug Abuse Advisory Council, to conform with the aforementioned Joint Memorandum Circular No. 2018-01.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Article IV, Section 1 of Ordinance No. SP-2791, S-2018 is hereby amended to correspond with the Joint Memorandum Circular No. 2018-01 issued by the Department of the Interior and Local Government (DILG) and the Dangerous Drugs Board (DDB), to be read as follows:

"ARTICLE IV. ANTI-DRUG ABUSE CAMPAIGN ORGANIZATION

SECTION 1. ORGANIZATION. - The Anti-Drug Abuse Campaign of Quezon City shall be implemented by the Quezon City Anti-Drug Abuse Advisory Council, composed of the following officials and organizations:

1.1 Quezon City Anti-Drug Abuse Board

- a) Chairperson - The City Mayor;
- b) Co-Chairperson - The City Vice Mayor;
- c) Vice Chairperson - The District Director, Quezon City Police District (QCPD);
- d) Member - Chairperson, Committee on Dangerous Drugs;
- e) Member - Chairperson, Committee on Health and Sanitation;

- f) *Member - Chairperson, Committee on Social Services;*
- g) *Member - Chairperson, Committee on Public Order and Security.*

1.2 *Quezon City Anti-Drug Abuse Advisory Council*

- a) *Chairperson - The City Mayor;*
- b) *Co-Chairperson - The City Vice Mayor;*
- c) *Vice Chairperson - The District Director, Quezon City Police District (QCPD);*

Members:

- a) *Chairperson, Committee on Dangerous Drugs;*
- b) *Chairperson, Committee on Health and Sanitation;*
- c) *Chairperson, Committee on Social Services;*
- d) *Chairperson, Committee on Public Order and Security;*
- e) *City Planning and Development Officer;*
- f) *Division of City Schools Superintendent;*
- g) *Social Services Development Department Head;*
- h) *City Health Officer;*
- i) *Executive Judge, Regional Trial Court or a Judge of QC RTC designated in writing by the RTC Executive Judge;*
- j) *City Prosecutor;*

- k) District Drug Enforcement Unit (DDEU) Officer, QCPD;
- l) Barangay and Community Relations Officer;
- m) President, Liga ng mga Barangay, Quezon City Chapter;
- n) President, SK Federation, Quezon City Chapter;
- o) Parole and Probation Board Officer;
- p) Public Assistance and Information Services Officer;
- q) Quezon City Drug Treatment and Rehabilitation Center, TAHANAN Administrator;
- r) City Director, Department of the Interior and Local Government, Quezon City Field Office (DILG-QC);
- s) Executive Director, Quezon City Muslim Consultative Council; and
- t) Two (2) duly-accredited civil society organization representatives.


