ORDINANCE NO. SP- 3120 , S-2022

AN ORDINANCE RECLASSIFYING AND CONVERTING INTO A RESIDENTIAL USE A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 265557 OWNED BY THE QUEZON CITY GOVERNMENT, PARTICULARLY DESCRIBED AS PARK STRIP LOT 9, BSD-10642 CONTAINING AN AREA OF ONE THOUSAND FORTY-EIGHT AND 40/100 (1,048.40) SQUARE METERS, MORE OR LESS, LOCATED AT INTERIOR ANONAS STREET, BARANGAY QUIRINO 3-A, PROJECT 3, QUEZON CITY.

WHEREAS, a certain parcel of land covered by Transfer Certificate of Title No. 265557 and owned by the Quezon City Government, particularly described as park strip Lot 9, Bsd-10642 containing an area of one thousand forty-eight and 40/100 (1,048.40) square meters, more or less, is located at Interior Anonas Street, Barangay Quirino 3-A, Project 3, Quezon City;

WHEREAS, the abovementioned park strip, upon actual site inspection by the Housing, Community Development and Resettlement Department (HCDRD), is presently occupied by at least 100 families;

WHEREAS, the present occupants are living in the said park strip for almost fifty (50) years and expressed their desire to avail of the housing program of the City;

WHEREAS, the Sangguniang Barangay of Quirino 3-A adopted Resolution No. 27, S-2021 requesting the Sangguniang Panlungsod for the conversion of the aforementioned park strip into a residential use;

WHEREAS, the Local Government Code of 1991 provides that the local Sangguniang Panlungsod may, through an ordinance, reclassify a parcel of land for other purpose;

WHEREAS, there is a need for a local legislative act to reclassify and convert the identified park strip into residential.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. - An Ordinance Reclassifying and Converting into a residential use a Parcel of Land covered by Transfer Certificate of Title No. 265557 and owned by Quezon City Government, particularly described as park strip Lot 9, Bsd-10642 containing an area of one thousand forty-eight and 40/100 (1,048.40) square meters, more or less, located at Interior Anonas Street, Barangay Quirino 3-A, Project 3, Quezon City.

SECTION 2. SEPARABILITY CLAUSE. - If any provision of this Ordinance is declared void or unconstitutional, the remaining portions shall not be affected and shall remain in full force and effect.
