ORDINANCE NO. SP-**3125**, S-2022

AN ORDINANCE AMENDING SUBPARAGRAPH B (3) OF PARAGRAPH A AND SUBPARAGRAPH B (3) OF PARAGRAPH B, BOTH UNDER SECTION 3 OF ORDINANCE NO. 3114, S-2022, ENTITLED "AN ORDINANCE REVISING ORDINANCE NO. SP-2273, S-2014, ENTITLED AN ORDINANCE ADOPTING THE SEAL OF GOOD HOUSEKEEPING IN ALL BARANGAYS OF QUEZON CITY, CONSOLIDATING THE AMENDMENTS PROVIDED IN ORDINANCE NOS. SP-2523, S-2016, SP-2588, S-2017, AND SP-2898, S-2020 AND INCORPORATING INDICATORS FOR COVID-19 RESPONSE."

*WHEREAS, Republic Act No. 11032 requires all government agencies including barangays to adhere to the principles of Ease of Doing Business (EODB);*

*WHEREAS, in light of this law, compliance with EODB should be one of the criteria for determining if a barangay achieved good local governance;*

*WHEREAS, compliance with EODB must be fully implemented by the Barangay Officials who are considered at the frontline service of their constituents;*

*WHEREAS, there is a need to further amend Ordinance No. SP-3114, S-2022 to provide a basis for the award and citation.*

**NOW, THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:**

**SECTION 1.** *Subparagraph b (3) of Paragraph A, Section 3 of Ordinance No. SP-3114, S-2022 shall now be read as follows:*

*“3. Compliance to Republic Act No. 9485 or the Anti-Red Tape Act and Republic Act No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018.”*

SECTION 2. Subparagraph b (3) of Paragraph B, Section 3 of Ordinance No. SP-3114, S-2022, shall also be amended to read as follows:

*“3. Compliance to Republic Act No. 9485 or the Anti-Red Tape Act and Republic Act No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018.”*


SECTION 3. REPEALING CLAUSE. - All local ordinances, rules and regulations or part thereof which are inconsistent with the provisions of this Ordinance, are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.
