AN ORDINANCE ESTABLISHING THE QUEZON CITY YOUTH DEVELOPMENT COUNCIL EXECUTIVE BOARD AND FOR OTHER PURPOSES.

WHEREAS, the State recognizes its responsibility to enable the youth to fulfill their vital role in nation-building and commits to the promotion and protection of the physical, moral, spiritual, intellectual, and social well-being of the Filipino Youth inculcating in them patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Republic Act No. 10742, otherwise known as the "Sangguniang Kabataan Reform Act of 2015", mandates the creation of the Local Youth Development Council in order to ensure the wide and multi-sectoral youth participation in local governance;

WHEREAS, Republic Act No. 7160, also known as the Local Government Code of 1991, states that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, according to the 2020 Census of Population and Housing, the Quezon City Youth (ages 15 to 30) comprises 27% of its total population;

WHEREAS, there is a need to establish the Quezon City Youth Development Council Executive Board (QCYDC-EB) in order to consolidate the full force of the Quezon City Government in addressing the various concerns and issues of the Quezon City youth population and providing vital and necessary services, programs, projects and activities to this sector.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. SHORT TITLE. - This Ordinance shall be known as the "Quezon City Youth Development Council Executive Board (QCYDC-EB) Ordinance of 2022".

SECTION 2. ESTABLISHMENT, MEMBERSHIP AND COMPOSITION. - The Quezon City Youth Development Council Executive Board (QCYDC-EB) is hereby organized with the following members:

- i. City Mayor Chairperson
- ii. President, Sangguniang Kabataan (SK) Federation Co-Chairperson
- iii. Head, Quezon City Youth Development Office Secretariat
- iv. Office of the City Vice Mayor
- v. Head, City Planning and Development Department
- vi. Chairperson, Committee on Education
- vii. Head, City Health Department
- viii. Head, Small Business and Cooperatives Development and Promotions Office (SBCDPO)
- ix. Head, Social Services Development Department (SSDD)
- x. Head, Barangay and Community Relations Department (BCRD)
- xi. Head, Public and Employment Services Office (PESO)
- xii. Head, Education Affairs Unit (EAU)
- xiii. Superintendent, Schools Division Office, Quezon City (SDO)
- xiv. President, Quezon City University (QCU)
- xv. City Director, Department of the Interior and Local Government (DILG)-Quezon City
- xvi. Representative, National Youth Commission
- xvii. Representative, TESDA-Quezon City

The QCYDC-EB may, as necessary, invite to its meetings and activities the other government agencies, NGOs, and experts, who have relevant expertise that may be useful to accomplish its functions enumerated under this Ordinance.

SECTION 3. FUNCTIONS AND RESPONSIBILITIES. - The QCYDC-EB shall be responsible for the following:

- i. Formulate policies and component programs in coordination with the various government agencies handling youth-related programs, projects and activities;
- ii. Coordinate and harmonize activities of all agencies and organizations in the city engaged in youth development programs;
- iii. Develop and provide support for the development and coordination of youth projects and design strategies to gain support and participation of the youth;
- iv. Assist the national government and government agencies in the promotion of programs, projects and activities in the local level;
- v. Assist the various government and non-government agencies in the identification and nomination of qualified participants to different programs, projects and activities;
- vi. Assist in the development and regularly review a Quezon City Youth Development Plan, in collaboration with Local Youth Development Council, relevant government agencies, NGOs and CSOs, and other stakeholders;
- vii. Ensure the operationalization and implementation of the City Youth Development Plan;
- viii. Strengthen collaboration between government agencies and CSOs involved in the implementation of the Quezon City Youth Development Plan;
- ix. Monitor the implementation of the CYDP, undertake mid-term assessments, including spending assessments, and evaluate its impact, every year for the first three (3) years and every three (3) years thereafter;

- x. Mobilize sources of funds for the implementation and evaluation of the CYDP;
- xi. Direct and require members to conduct monitoring and evaluation of all programs, policies, and services, undertaken within their respective mandates, and to submit an annual report;
- xii. Advocate and recommend for policy reforms to the QC Council, Congress, and other government agencies or departments to strengthen the City's response that will institutionalize or continue the interventions required in addressing the gaps to the various issues and concerns of young people;
- xiii. Identify gaps in the City's response on the part of government agencies and its partners from the civil society and international organizations in order to develop and implement the initial interventions required to address such gaps; and
- xiv. Submit an annual accomplishment/progress report on the accomplishments under the QCYDP to the Office of the Mayor, City Council, and as needed, to the related national government agencies.

SECTION 4. MEETINGS AND QUORUM. - The QCYDC-EB shall meet at least once every quarter at any venue and the notice of meeting, including the agenda, shall be sent to members at least two (2) weeks before the scheduled meeting, except in cases of emergencies, in which case, a 48-hour notice shall be sufficient.

The presence of the Chairperson and at least seven (7) permanent members of the QCYDC-EB shall constitute a quorum to do business, and a majority vote of those present shall be sufficient to render decisions.

SECTION 5. APPROPRIATIONS. - The Quezon City Government shall incorporate in its Annual Budget such amount as maybe necessary for the operation and effective functioning of the Quezon City Youth Development Council Executive Board (QCYDC-EB).

SECTION 6. REPEALING CLAUSE. - All ordinances, resolutions, executive issuances, or rules and regulations, or parts thereof, whose provisions are inconsistent with or contrary to the provisions of this Ordinance, are hereby deemed repealed, amended, or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE. - If, for any reason, any section or provision of this Ordinance is held unconstitutional or invalid, the other sections or provisions hereof shall not be affected thereby.

SECTION 8. EFFECTIVITY CLAUSE. - This ordinance shall take effect immediately upon its approval.
