ORDINANCE NO. SP- 3173, S-2022

AN ORDINANCE ALLOWING THE NEW TRAFFIC SCHEME OF BARANGAY NAGKAISANG NAYON AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a)(5)(v) and (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides for the powers, duties and functions of the Sangguniang Panlungsod:

(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same, xxx.

(vi) Regulate traffic on all streets and bridges, prohibit encroachment or obstacles thereon and when necessary in the interest of public welfare, xxx";

WHEREAS, the Sangguniang Barangay of Nagkaisang Nayon passed Resolution No. 343, S-2022, entitled "Resolution Requesting the City Council to enact an Ordinance pertaining to the flow of Traffic on Traffic Management of Barangay Nagkaisang Nayon";

WHEREAS, due to the increase in the number of vehicles passing through the streets causing traffic problems in the said Barangay, it is necessary to implement a new traffic scheme to maintain peace and order in the community;

WHEREAS, there is a need to prescribe a systematic, organized and fully implementable mechanism of maximizing the limited road space available to ensure the smooth and unhampered flow of traffic;

WHEREAS, motorists often fail to observe road courtesy and discipline, rules and regulations while operating motor vehicles, creating traffic accident prone incidents and near collision occurrences;

WHEREAS, there is an urgent need to address all traffic problems, and put things in their proper perspective by providing for an efficient traffic management, to maintain an orderly and smooth traffic and sufficient movement of motorists and the residents of Barangay Nagkaisang Nayon;

WHEREAS, the heavy volume of vehicles entering Barangay Nagkaisang Nayon especially during peak/rush hours compelled the Sangguniang Barangay of Nagkaisang Nayon, as a matter of necessity, to adopt a traffic route plan to determine the One Way Traffic, and regulate the entry of big container vans and similar ten (10) wheeler trucks entering secondary roads of the Barangay;

WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. - This Ordinance shall be known as the "Traffic Management of Barangay Nagkaisang Nayon".

SECTION 2. SCOPE. - This Ordinance shall apply to all motorists, residents and non-residents, passing through the streets of this barangay who are required to obey by this new barangay traffic scheme.

SECTION 3. TRAFFIC SCHEME. - *The designation and implementation of roads and streets are as follows:*

- 3.1 *Streets are considered as "One-Way Traffic": Molave Drive 1 entrance one-way traffic straight ahead of Ogoy Street right turn to Molave Drive 2 Exit to Damong Maliit Road to destination.*
- 3.2 *"No Entry", heavy vehicles such as bulldozers, buses, container trucks, big container vans and ten (10) wheeler trucks use for delivery shall be prohibited to stay more than ten (10) minutes, unless permitted by the barangay along Damong Maliit Road from Gen. Luis to Queensland Subdivision and vice versa.*
- 3.3 *Business establishments may secure an exemption to pass along Damong Maliit Road, Barangay Nagkaisang Nayon from Traffic and Transport Management Department (TTMD) with Barangay Clearance from the concern barangay.*

SECTION 4. *The Traffic and Transport Management Department of this City, the Metropolitan Manila Development Authority and the Barangay Nagkaisang Nayon shall insure the production and installation of the different traffic signage to be conspicuously displayed in the affected areas prior to the implementation of the traffic scheme system in this barangay.*

SECTION 5. PENALTIES. - *Any person or persons found violating the provision/s of this Ordinance shall be penalized in accordance with Article XXV of Ordinance No. SP-2785, S-2018, also known as the Quezon City Revised Traffic Management Code of 2018, as amended.*

SECTION 6. *The Traffic and Transport Management Department of this City, Philippine National Police Quezon City Station and the Barangay Public Safety Officer (BPSO) of Barangay Nagkaisang Nayon personnel shall ensure the strict implementation of this Ordinance.*

SECTION 7. REPEALING CLAUSE. - *All Quezon City Ordinance, Resolution, Executive Order, Memorandum Circular and Administrative Regulation, or parts thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.*

SECTION 8. SEPARABILITY CLAUSE. - *If for any reason or reasons, any part or provision of this Ordinance is held unconstitutional or invalid, the other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.*
