**AN ORDINANCE REGULATING STREET PARKING AND TRAFFIC FLOW
IN BARANGAY SAN ANTONIO, DISTRICT I, QUEZON CITY**

WHEREAS, Section 16 (General Welfare Clause) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, and to maintain peace and order and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 458 of the same Code grants the Sangguniang Panlungsod, as the local legislative body, the power to enact ordinances, approve resolutions and appropriate funds for the general welfare of the City and its inhabitants, exercise the corporate powers of the City properly, and to:

1. *Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks, and other public places and approve the construction, improvement, repair, and maintenance of the same; establish bus and vehicle stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public; regulate garages and the operation of conveyances for hire; designate stands to be occupied by public vehicles when not in use; regulate the putting up of signs, signposts, awnings and awning posts on the streets; and provide for the lighting, cleaning, and sprinkling of streets; and public places;*
2. *Regulate traffic on all streets and bridges, prohibit obstacles or encroachments thereon, and when necessary, in the interest of public welfare, authorize the removal or encroachments and illegal constructions in public places;*
3. *Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;*

WHEREAS, the Sanggunian of Barangay San Antonio, District I, Quezon City passed a resolution requesting the Sangguniang Panlungsod of Quezon City to enact an ordinance to effect one-side parking and regulate the flow of traffic in the streets within the territorial jurisdiction of the said Barangay, as street parking has become inevitable due to the limited spaces for residents, transients, and visitors alike, aggravated on occasions during holidays and activities necessitating assemblies or gatherings of many persons.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. SHORT TITLE. - This Ordinance shall be known and cited as the "Barangay San Antonio Street Parking Ordinance".

SECTION 2. DECLARATION OF POLICY. - It is hereby declared a policy of Quezon City to adopt strict but practicable street parking and traffic rules that improve the flow of traffic with minimal monitoring and enforcement requirements, deter obstruction and encroachments, enhance emergency response, encourage cleanliness and orderliness, and prohibit private occupancy of public roads.

SECTION 3. NO-PARKING ZONE. - The following thoroughfares within the territorial jurisdiction of Barangay San Antonio are hereby declared to be No-Parking Zones:

- a. Roosevelt Avenue;*
- b. West River Side Street;*
- c. Baler Street;*
- d. Judge Juan Luna Street;*
- e. M.H. Del Pilar Street;*
- f. Atty. Pat Senador Street; and*
- g. Sto. Niño Street - from Roosevelt Avenue to San Antonio Street;*

as indicated by appropriate signs or signals.

All motor vehicles, including Public Utility Vehicles, are not allowed overnight parking or prolonged stoppage in the foregoing thoroughfares.

Motor vehicles shall not park or otherwise obstruct the ingress and egress to establish road right-of-way, private or public driveways, hospitals, police and fire stations, and other government buildings and public utilities.

SECTION 4. OTHER PROHIBITED PARKING. - No person shall reserve a portion of or space within the streets of Barangay San Antonio as personal parking spaces, and no vehicle shall be parked heading against the flow of traffic or within six (6) meters of an intersection, on curves, and blind spots.

SECTION 5. ONE-WAY TRAFFIC. - The following streets within the territorial jurisdiction of Barangay San Antonio are hereby declared to be One-Way Streets:

- a. Batangas Street to Adams Street - from Roosevelt Avenue to M.H. Del Pilar Street;*

- b. *Capillan Street - from San Jose Street to Sto. Niño Street;*
- c. *San Jose Street - from San Antonio Street to Capillan Street;*

as indicated by appropriate signs and signals.

SECTION 6. ONE-SIDE PARKING. - *A One-Side Parking scheme shall be implemented in the following streets within the territorial jurisdiction of Barangay San Antonio:*

a. *Left-Side Parking -*

- (1) *Lincoln Street - from Atty. Pat Senador Street to West River Side Street;*
- (2) *Tolentino Street - from Atty. Pat Senador Street to West River Side Street;*
- (3) *Fernandez Street - from San Antonio Street to West River Side Street;*
- (4) *Piopongco Street - from San Antonio Street to Capillan Street;*
- (5) *De Jesus Street - from Judge Juan Luna Street to West River Side Street;*
- (6) *Capillian Street - from San Jose Street to M.H. Del Pilar Street;*
- (7) *Batangas Street - from Roosevelt Street to Montenegro Street;*
- (8) *Samonte Street - from Montenegro Street to West River Side Street;*
- (9) *Esquivel Street - from Judge Juan Luna Street to Ana Maria Street;*

b. *Right-Side Parking -*

- (1) *Santiago Street - from Atty. Pat Senador Street to West River Side Street;*



- (2) *San Antonio Street - from Atty. Pat Senador Street to Batangas Street;*
- (3) *Sto. Niño Street - from San Antonio Street to Capillian Street;*
- (4) *Guerrero Street - from San Antonio Street to Capillian Street;*
- (5) *Cruz Street - from San Antonio Street to West River Side Street;*
- (6) *Umandal Street - from M.H. Del Pilar Street;*
- (7) *Domingo Street - from M.H. Del Pilar Street;*
- (8) *P. Garcia Street - from M.H. Del Pilar Street;*
- (9) *Montenegro Street - from M.H. Del Pilar Street;*
- (10) *Lopez Street - from M.H. Del Pilar Street;*
- (11) *Evardoni Street - from M.H. Del Pilar Street to Sta. Ana Street;*
- (12) *Sta. Fe Street - from Santiago Street to San Jose Street;*
- (13) *Adams Street - from M.H. Del Pilar Street to Batangas Street;*
- (14) *Batangas Street - from Adams Street to Roosevelt Street;*
- (15) *Ana Maria Street - from Judge Juan Luna Street to Esquivel Street.*

SECTION 7. ENTRY POINTS AND LOADING HOURS. - Container vans and large vehicles, as defined by the Traffic and Transport Management Department, shall load and unload merchandise from 10:00 in the morning until 3:00 in the afternoon only through the following Entry Points:

- a. *Atty. Pat Senador Street;*



- b. M.H. Del Pilar Street;
- c. West River Side Street;
- d. E. Porto Street;
- e. De Jesus Street;
- f. Sta. Fe Street;
- g. San Antonio Street;
- h. Santiago Street;
- i. Tolentino Street;

as indicated by appropriate signs and signals.

SECTION 8. PENALTIES. - Any violation under this Ordinance shall be meted a penalty in accordance with Ordinance No. SP-3172, S-2023 or the Metro Manila Traffic Code of 2023.

- a. For violations under Section 3 (No Parking Zone), Section 4 (Other Prohibited Parking), Section 6 (One-side Parking), Section 7 (Entry Point and Loading Hours) of this Ordinance, there shall be a fine of One Thousand Pesos (Php1,000.00), if the vehicle is attended by the driver; and Two Thousand Pesos (Php2,000.00) and impoundment of the vehicle, if unattended.
- b. For violation under Section 5 (One-way Traffic) of this Ordinance, there shall be a fine amounting to Two Thousand Pesos (Php2,000.00) for the person driving the vehicle and a fine of Five Thousand Pesos (Php5,000.00) in case the violation caused physical injuries or damage to properties, without prejudice to the civil and criminal liability of the driver, registered owner or operator of the motor vehicle.

SECTION 9. IMPLEMENTING RULES AND REGULATIONS. - The Traffic and Transport Management Department (TTMD) shall, in consultation with Barangay San Antonio, promulgate rules and regulations to implement this Ordinance.

SECTION 10. REPEALING CLAUSE. - All ordinances and resolutions or parts thereof that are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.



SECTION 11. SEPARABILITY CLAUSE. - If any part of this Ordinance should be annulled or declared ineffective by a court of competent jurisdiction, the remaining parts unaffected by the declaration shall continue to be in full force and effect.

SECTION 12. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon posting in at least three (3) conspicuous places in Barangay San Antonio.
