ORDINANCE NO. SP- 49 E, S-97

AN ORDINANCE FURTHER AMENDING ORDINANCE NO. SP-481, S-96, "AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 1997 IN THE TOTAL AMOUNT OF THREE BILLION EIGHT HUNDRED FORTY MILLION ONE HUNDRED NINETY ONE THOUSAND ONE HUNDRED PESOS (P3,840,191,100.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR THE YEAR 1997, AND APPROVING THE NECESSARY FUNDS FOR THE PURPOSE." BY DELETING SECTIONS 3 AND 4 THEREOF.

WHEREAS, Section 3 of Ordinance No. SP-481, S-96 entitled, "AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 1997 IN THE TOTAL AMOUNT OF THREE BILLION EIGHT HUNDRED FORTY MILLION ONE HUNDRED NINETY-ONE THOUSAND ONE HUNDRED PESOS (P3,840,191,100.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR THE YEAR 1997, AND APPROVING THE NECESSARY FUNDS FOR THE PURPOSE" provides that lifting of twenty percent (20%) reserve requirement on all maintenance and operating expenses of all City Departments/Offices can be done only through resolution of the City Council, subject to the availability of funds;

WHEREAS, there is a need to delete said Section 3 of Ordinance No. SP-481, S-96, since the prerogative to approve releases and/or disbursements of funds belongs to the Chief Executive;
