ORDINANCE NO. SP- 518, S-97

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF FOREST SIDE VILLAS (TWO-STOREY TOWNHOUSES : 144-UNITS), CONTAINING AN AGGREGATE AREA OF SIX THOUSAND NINE HUNDRED EIGHTY-SIX SQUARE METERS AND FOURTEEN SQUARE DECIMETERS (6,986.14 SQ.M.) COVERED BY TRANSFER CERTIFICATES OF TITLE NOS. 128527, RT-76202, N-155859, N-141759, N-141740, N-141743 AND N-141744 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF LABRADOR DEVELOPMENT CORPORATION, LOCATED AT SITIO MABILOG, BGY. CULIAT, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY LABRADOR DEVELOPMENT CORPORATION, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92 AND BATAS PAMBANSA BILANG 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Forest Side Villas (Two-Storey Townhouses : 144-Units) containing an aggregate area of six thousand nine hundred eighty-six square meters and fourteen square decimeters (6,986.14 sq.m.), covered by Transfer Certificates of Title Nos. 128527, RT-76202, N-155859, N-141759, N-141740, N-141743 and N-141744 in the name of Labrador Development Corporation, located at Sitio Mabilog, Barangay Culiat, Quezon City, Metro Manila, as applied for by Labrador Development Corporation represented by Ms. Fina R. Bustos is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-92 and Batas Pambansa Bilang 220, details of which are as follows:
