ORDINANCE NO. SP- 522, S-97

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF SINAGTALA RESIDENTIAL SUBDIVISION (138-LOTS), CONTAINING AN AGGREGATE AREA OF FIVE THOUSAND SIX HUNDRED THIRTY-SIX (5,636) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NOS. 128489 TO 128499 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SINAGTALA HOMEOWNERS ASSOCIATION, INC., LOCATED AT FEBRUARY STREET, PROJECT 8, BARANGAY BAHAY TORO, QUEZON CITY, METRO MANILA, AND AS APPLIED FOR BY SINAGTALA HOMEOWNERS ASSOCIATION INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of Sinagtala Residential Subdivision (138-Lots), containing an aggregate area of Five Thousand Six Hundred Thirty-Six (5,636) square meters covered by Transfer Certificates of Title Nos. 128489 to 128499 in the name of Sinagtala Homeowners Association, Inc., located at February St., Project 8 Brgy., Bahay Toro, Quezon City, Metro Manila, and as applied for by Sinagtala Homeowners Association, Inc., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-92 and Batas Pambansa Blg. 220, details of which are as follows:
