ORDINANCE NO. SP- 5 6 1 ,-S-97

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL SUBDIVISION: BP 220 MODEL Æ, (49LOTS), CONTAINING AGGREGATE AREA OF THREE THOUSAND NINETY-SEVEN (3,097) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 114507, 114508, 114509 AND 114520 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF BIYAYA CORPORATION (VENDOR), AND LOCATED AT MALIPAKA STREET, MALIGAYA PARK SUBDIVISION, BARANGAY **PASONG** PUTIK, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY PINAGKAISAHANG LAKAS (PIGLAS) SA MALIGAYA HOMEOWNERS ASSOCIATION, INC., (VENDEE), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a residential subdivision: BP 220 Model 'E' (49lots), containing an aggregate area of Three Thousand Ninety-Seven (3,097) square meters, covered by Transfer Certificates of Title Numbered 114507, 114508, 114509 and 114520 of the Registry of Deeds of Quezon City, registered in the name of Biyaya Corporation (vendor), and located at Malipaka St., Maligaya Park Subdivision, Barangay Pasong Putik, Novaliches, Quezon City, Metro Manila, as applied for by Pinagkaisahang Lakas (PIGLAS) sa Maligaya Homeowners Association, Inc., (vendee), is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-92, and Batas Pambansa Blg. 220, details of which are as follows:
