ORDINANCE NO. SP- 5 7 8 -, S-97

AN ORDINANCE APPROVING THE RESIDENTIAL SUBDIVISION PLAN OF LOTS 1, 2, 3, 4, 5 AND 6, REL-13-000332 (26 LOTS), CONTAINING AN AGGREGATE AREA OF NINE THOUSAND ONE HUNDRED EIGHTY-NINE (9,189) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-173884 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SINO-FIL REALTY AND DEVELOPMENT CORPORATION, AND LOCATED AT 8TH STREET CORNER GILMORE STREET, BARANGAY MARIANA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY SINO-FIL REALTY AND DEVELOPMENT CORPORATION REPRESENTED BY MR. JUAN T. GARCIA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The residential subdivision plan of Lots 1, 2, 3, 4, 5, and 6, Rel-13-000332 (26 lots), containing an aggregate area of Nine Thousand One Hundred Eighty-Nine (9,189) square meters covered by Transfer Certificate of Title No. 173884 of the Registry of Deeds of Quezon City, registered in the name of Sino-Fil Realty and Development Corporation, and located at 8th Street, corner Gilmore St., Barangay Mariana, Quezon City, Metro Manila, as applied for by Sino-Fil Realty Development Corporation represented by Mr. Juan T. Garcia, is hereby approved subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-92, details of which are as follows:
