ORDINANCE NO. SP- 592 -S-97

AN ORDINANCE APPROVING RESOLUTION NO. 6, S-97, OF THE BOARD OF APPEALS RECTIFYING THE POSITION TITLES AND/OR SALARY GRADES OF ADVERSELY AFFECTED/AGGRIEVED EMPLOYEES UNDER THE QUEZON CITY GOVERNMENT IN ACCORDANCE WITH THE PROVISIONS OF R.A. 6758, OTHERWISE KNOWN AS THE "COMPENSATION AND POSITION CLASSIFICATION LAW" AND APPROPRIATING THE AMOUNT OF SIX MILLION THREE HUNDRED NINETY-FIVE THOUSAND SIX HUNDRED NINETY-FIVE PESOS (P6,395,695.00) TO COVER THE FUNDING REQUIREMENTS THEREFOR TO BE TAKEN FROM ANY AVAILABLE FUNDS.

WHEREAS, the Board of Appeals of Quezon City created under Resolution No. SP-199, S-93, of the City Council provided in part the rectification of the position titles and salary grades of all aggrieved employees of the Quezon City government adversely affected by the inequitable implementation of the position classification and salary standardization law;

WHEREAS, the Board of Appeals, thus created, after careful, thorough and comprehensive evaluation of the appeals of these concerned personnel has favorably recommended for approval the requests for rectification and standardization of the One Hundred and One (101) employees of the various departments and offices of the city government;

WHEREAS, this approval shall require the allocation of the necessary amount in the budget for the salary differential of these affected personnel;
