ORDINANCE NO. SP- 694 S-98

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF KONSTI-A WITH TEN (10) LOTS (CMP), CONTAINING AN AREA OF FIVE HUNDRED THIRTY-THREE (533) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 67037 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF KOMUNIDAD NA NAGHAHANGAD NG SARILING TIRAHAN HOMEOWNERS ASSOCIATION, INC., AND LOCATED AT LOT 7, BLOCK 6, PCS-2874, CONGRESSIONAL ROAD, BARANGAY BATASAN HILLS, QUEZON CITY, AS APPLIED FOR BY THE KOMUNIDAD NA NAGHAHANGAD NG SARILING TIRAHAN HOMEOWNERS ASSOCIATION, INC. REPRESENTED BY MR. DALMACIO B. BALILLA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of KONSTI-A with ten (10) lots (CMP), containing an area of Five Hundred Thirty Three (533) square meters, covered by Transfer Certificate of Title No. 67037 of the Registry of Deeds of Quezon City, registered in the name of Komunidad na Naghahangad ng Sariling Tirahan Homeowners Association, Inc., and located at Lot 7, Block 6, Pes-2874, Congressional Road, Barangay Batasan Hills, Quezon City, as applied for by the Komunidad na Naghahangad ng Sariling Tirahan Homeowners Association, Inc., represented by Mr. Dalmacio B. Balilla, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
