ORDINANCE NO. SP- 728 , S-98

AN ORDINANCE AMENDING ORDINANCE NO. SP-691, S-98, SO AS TO CORRECT THE MISTAKEN DESCRIPTIONS OF THE PROPERTIES SUBJECT OF THE DEVELOPMENT PERMIT RESULTING FROM THE INADVERTENT INTERCHANGES IN THE TRANSFER CERTIFICATES OF TITLES.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The title of Ordinance No. SP-691, S-98 is hereby amended to read as follows:

"AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF QUEENSLAND III ONE-STOREY TOWNHOUSES WITH NINETY-EIGHT (98) UNITS, CONTAINING AN AGGREGATE AREA OF FIVE THOUSAND FIVE HUNDRED TWELVE (5,512) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-155994, 118938 AND N-155995 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SPOUSES TEODORO RAMOS & TRINIDAD RAMOS, TRINIDAD SAN DIEGO-RAMOS, M/T TEODORO RAMOS & SPOUSES MIGUEL SAN DIEGO AND DIEGA CRUZ, RESPECTIVELY, AND LOCATED AT DAMONG MALIT, BARANGAY NAGKAISANG NAYON, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY TEODORO N. RAMOS, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220."

SECTION 2. Section 1 of Ordinance No. SP-691, S-98 is hereby amended in conformity with the title, as amended, in Section 1 hereof, to read as follows:
