AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF KONSTI-B (BP BLG. 220) WITH 12-LOTS: COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED NINETY-NINE (599) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 67038 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME SARILING KOMUNIDAD NA NAGHAHANGAD NG TIRAHAN HOMEOWNERS ASSOCIATION, INC., AND LOCATED AT LOT NO. 12, BLOCK 6, PCS-2874, LEGISLATIVE ROAD, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE KOMUNIDAD TIRAHAN **HOMEOWNERS** NAGHAHANGAD NG SARILING ASSOCIATION, INC., REPRESENTED BY MR. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
