ORDINANCE NO. SP- 731 -98

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF KONSTI-B (BP BLG. 220) WITH 12-LOTS : COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED NINETY-NINE (599) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 67038 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF KOMUNIDAD NA NAGHAHANGAD NG SARILING TIRAHAN HOMEOWNERS ASSOCIATION, INC., AND LOCATED AT LOT NO. 12, BLOCK 6, PCS-2874, LEGISLATIVE ROAD, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE KOMUNIDAD NA NAGHAHANGAD NG SARILING TIRAHAN HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY MR. DALMACIO B. BALILLA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
