AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LE VENDOME I : 2-STOREY TOWNHOUSES WITH ATTIC (7 UNITS), CONTAINING AN AREA OF SIX HUNDRED FOURTEEN (614) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-188094, N-188095, N-188096, N-188097, N-188098, N-188099, N-188100 AND N-188101 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ANTONIO T. SIMANGAN, AND LOCATED AT LOT NOS. 2-A TO 2-H (LRA) PSD-359905, NO. 61 MATAHIMIK ST., BARANGAY TEACHERS' VILLAGE WEST, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY ANTONIO T. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of LE VENDOME I: 2-Storey Townhouses with Attic (7 units), containing an area of Six Hundred Fourteen (614) square meters, covered by Transfer Certificates of Title Numbered N-188094, N-188095, N-188096, N-188097, N-188098, N-188099, N-188100 and N-188101 of the Registry of Deeds of Quezon City, registered in the name of Antonio T.
