AN ORDINANCE APPROVING THE SUBDIVISION DEVELOPMENT PROJECT OF CORINTHIAN HILLS RESIDENTIAL SUBDIVISION WITH THIRTY-TWO (32) COMMERCIAL LOTS AND ONE HUNDRED SIXTY-NINE (169) RESIDENTIAL LOTS, CONTAINING AN AGGREGATE AREA OF ONE HUNDRED FOUR THOUSAND NINE HUNDRED AND SIXTY ONE (104,961) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 98383 TO 98411, 58076, 58077 AND 58157 OF THE REGISTRY OF DEEDS, QUEZON CITY, AND REGISTERED IN THE NAME OF AND BEING DEVELOPED BY MEGAWORLD PROPERTIES AND HOLDINGS., INC., AND LOCATED AT TEMPLE DRIVE, BARANGAY UGONG NORTE, QUEZON CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER ORDINANCE NO. SP-56, S-93, AND STRICT COMPLIANCE WITH EXISTING LAWS.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision development project, plans & programs of work of Corinthian Hills, residential subdivision with Thirty-Two (32) commercial lots and One Hundred and Sixty Nine (169) residential lots, containing an aggregate area of One Hundred Four Thousand Nine Hundred and Sixty One (104,961) Square Meters covered by Transfer Certificates of Title Numbered 98383 to 98411, 58076, 58077 and 58157 of the Registry of Deeds, Quezon City, and registered in the name of and being developed by MEGAWORLD Properties and Holdings, Inc., and located at Temple Drive, Barangay Ugong Norte, Quezon City, Metro Manila, is hereby approved, subject to the conditions prescribed under Ordinance No. SP-56, S-93 and strict compliance with existing laws, details are as follows:
