ORDINANCE NO. SP- 772, S-99

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL SUBDIVISION WITH 22 LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND (1,000) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-196229 AND N-196230 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF NEILL PROPERTY (PHASE II) HOMEOWNERS ASSOCIATION, INC., AND LOCATED AT LOTS NUMBERED 4 & 5 (LRC) PSD-2901, UPPER BANLAT ROAD, BARANGAY TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE LATTER, REPRESENTED BY MS. ERNA M. ANTONIO, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT with 22-lots, Community Mortgage Program, containing an area of One Thousand (1,000) square meters, covered by Transfer Certificate of Title Numbered N-196229 and N-196230 of the Registry of Deeds of Quezon City, registered in the name of Neill Property (Phase II) Homeowners Association, Inc., and located at Lots No. 4 & 5 (LRC) Psd-2901, Upper Banlat Road, Barangay Tandang Sora, Quezon City, Metro Manila, as applied for by the latter, represented by Ms. Erna M. Antonio, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
