ORDINANCE NO. ~~SP-818~~, S-99

AN ORDINANCE RECLASSIFYING A PORTION OF A PARCEL OF LAND EQUIVALENT TO AN AREA OF SIX HUNDRED (600) SQUARE METERS, IDENTIFIED AS BLOCK 7, (LRC) PCS-10318 WITH A TOTAL AREA OF THREE THOUSAND (3,000) SQUARE METERS, LOCATED AT MOLAVE ROAD, DIAMOND HILLS SUBDIVISION, BARANGAY PAYATAS, DISTRICT II, THIS CITY, FROM ITS PRESENT DESCRIPTION AS AN OPEN SPACE INTO AN INSTITUTIONAL PROPERTY OF THE CITY GOVERNMENT.

WHEREAS, the government of Australia Agency for International Development (AusAID) has approved Project PHI 5478, more particularly known as "The Street Children Nutrition and Education" project which is currently implemented in thirteen (13) local government units in the country;

WHEREAS, Quezon City, having been identified as those with considerable number of street children, has been selected as one of the implementors of the project due to its capacity to carry out and sustain similar project;

WHEREAS, under the revised PHI 5478 Plan of Operations, one of the outputs of the project is the construction of a Social Development Center (SDC) to support Quezon City's social growth and development-related program and help ensure project sustainability;

WHEREAS, the City Council has adopted Resolution No. 1164, S-99, dated May 18, 1999, authorizing the City Mayor to enter into a Memorandum of Agreement with the Department of Interior and Local Government (DILG) for the construction and maintenance of a Social Development Center subject for ratification by the City Council;

WHEREAS, a parcel of land identified as Block 7, (LRC) PCS-10318 located at Molave Road, Diamond Hills Subdivision, District II, this City, classified as an OPEN SPACE and containing an aggregate area of three thousand (3,000) square meters, is found to be the most suitable area for the construction of said building;
