AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH 26-LOTS, "GLAD" PROJECT, CONTAINING AN AREA OF ONE THOUSAND THIRTY-EIGHT (1,038) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-15716 OF THE REGISTRY OF DEEDS OF QUEZON CITY AND LOCATED AT LOT NO. B-11 (LRC) PSD 6737, NO. 9 IPIL STREET. FERIA, BARANGAY OLD BALARA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE NAGKAISANG MGA PUSO AT DAMDAMIN SA IPIL-BALARA ASSOCIATION, INC., REPRESENTED BY MR. HONORATO S. BASILIO, IS HEREBY APPROVED, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93.

SECTION 1.
