ORDINANCE NO. SP- 856 , S-2000

AN ORDINANCE AMENDING THE PENAL PROVISIONS OF ALL ORDINANCES RELATING TO WASTE AND GARBAGE COLLECTION AND DISPOSAL AND LITTERING SUCH AS, BUT NOT LIMITED TO, ORDINANCE NO. NC-106, S-89; ORDINANCE NO. NC-118, S-89; ORDINANCE NO. NC 172, S-90; ORDINANCE NO. SP-111, S-93, PRESCRIBING A UNIFORM AND GRADUATED PENALTIES THEREFOR, AND DEPUTIZING THE ELECTED BARANGAY OFFICIALS TO HELP IN THE IMPLEMENTATION THEREOF.

WHEREAS, Section 458 (1) (iii) of R.A. No. 7160, also known as the Local Government Code of 1991, empowers the City Council to approve ordinances and impose a penalty of a fine not exceeding Five Thousand Pesos (P5,000.00) or an imprisonment of not exceeding one (1) year, or both such fine and imprisonment at the discretion of the Court, for violation of the city ordinance;

WHEREAS, pursuant to Section 458 (4) (xiii) of the same Code, the City Council is also authorized to enact ordinances prohibiting "littering and placing or throwing of garbage, refuse and other filth and wastes";

WHEREAS, trash or garbage littering is one of the major problems besetting the city which if left unchecked or if not otherwise properly managed, could contribute in the outbreak of epidemic, and cause flooding that may result to untold misery to our residents:

WHEREAS, in order to put more "teeth" into the city's anti-littering campaign, and to insure the effective implementation of the ordinances covering the said campaign and for a more efficient system of solid waste and garbage collection and disposal or throwing of garbage and refuse, there is a need to impose a uniform and graduated penalty for violation of the provisions thereof and to deputize the elected barangay officials for their entorcement.
