## ORDINANCE NO. SP- 8 6 0 - 2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH 25-LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF NINE HUNDRED SIXTY-FIVE (965) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-20384 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF MARIA CORAZON UY, AND LOCATED AT LOT 13, BLOCK 5, (LRC) PSD-4786; DOÑA ISDORA STREET, BARANGAY HOLY SPIRIT, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY FAUSTINO HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY MR.
