ORDINANCE NO. SP- 8762, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF AN NHA-ZIP SITIO MALIGAYA HOUSING PROJECT (BP BLG. 220) WITH TWO HUNDRED THIRTY-SEVEN (237) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF EIGHTEEN THOUSAND FOUR HUNDRED THIRTY-ONE SQUARE METERS AND FORTY SQUARE DECIMETERS (18,431.40 SQ.M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-153517 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF NATIONAL HOUSING AUTHORITY (NHA), AND LOCATED AT BLOCK 53, PCS-4865, BAYANIHAN DRIVE, SITIO MALIGAYA, PROJECT 8, BRGY. BAHAY TORO, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY NHA, REPRESENTED BY MS. GERONIMA B. ANGELES, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of an NHA-ZIP Sitio Maligaya Housing Project (BP Blg. 220) with Two Hundred Thirty-Seven (237) lots, Community Mortgage Program, containing an area of Eighteen Thousand Four Hundred Thirty-One square meters and Forty square decimeters (18,431.40 sq.m.), covered by Transfer Certificate of Title No. N-153517 of the Registry of Deeds of Quezon City, registered in the name of National Housing Authority (NHA), and located at Block 53, Pcs-4865, Bayanihan Drive, Sitio Maligaya, Project 8, Brgy. Bahay Toro, Quezon City, Metro Manila, as applied for by NHA, represented by Ms. Geronima B. Angeles, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa 220.
