ORDINANCE NO. SP- 887 S-2000

APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FOUR (4) LOTS, CONTAINING AN AREA OF TWO HUNDRED FORTY (240) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-57965 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ROSA B. CARINGAL, AND LOCATED AT LOT 19, BLOCK 40, PSD-14959, IRIGA STREET, BARANGAY SAN ISIDRO LABRADOR, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT (BP Blg. 220) with Four (4) lots, containing an area of Two Hundred Forty (240) square meters, covered by Transfer Certificate of Title Numbered RT-57965 of the Registry of Deeds of Quezon City, registered in the name of Rosa B.
