## ORDINANCE NO. SP- 8 9 0 - S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH SIXTEEN (16) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FOUR HUNDRED METERS COVERED BYTRANSFER (459)SQUARE FIFTY-NINE CERTIFICATE OF TITLE NUMBERED N-200549, OF THE REGISTRY OF DEEDS OF QUEZON CITY REGISTERED IN THE NAME OF KAAKIBAT NG KABALIKAT I & II HOMEOWNERS ASSOCIATION, INC., LOCATED AT LOT 20-I (LRC) PSD-16526, 179 UPPER BANLAT, BARANGAY TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE LATTER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.
