ORDINANCE NO. SP- 890 - S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP Blg. 220) WITH SIXTEEN (16) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FOUR HUNDRED FIFTY-NINE (459) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-200549, OF THE REGISTRY OF DEEDS OF QUEZON CITY REGISTERED IN THE NAME OF KAAKIBAT NG KABALIKAT I & II HOMEOWNERS ASSOCIATION, INC., LOCATED AT LOT 20-I (LRC) PSD-16526, 179 UPPER BANLAT, BARANGAY TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE LATTER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA Blg. 220.

SECTION 1. The subdivision plan of a Residential Housing Project (BP Blg. 220) with sixteen (16) lots, Community Mortgage Program, containing an area of Four Hundred Fifty-Nine (459) square meters covered by Transfer Certificate of Title Numbered N-200549, of the Registry of Deeds of Quezon City registered in the name of Kaakibat ng Kabalikat I & II Homeowners Association, Inc., located at Lot 20-I (LRC) Psd-16526, 179 Upper Banlat, Barangay Tandang Sora, Quezon City, Metro Manila, as applied for by the latter, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
