ORDINANCE NO. SP- 908, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FIFTEEN (15) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SIX HUNDRED SQUARE METERS AND TWENTY SQUARE DECIMETERS (600.20 SQ. M.), COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 82491, 82492 & 82493, OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAMES OF MATILDE T. REYES, AURORA T. CHONG AND RODRIGO Q. TERANIA, RESPECTIVELY, AND LOCATED AT LOTS 122-A, 122-B & 122-C, PSD-007404-022395-D, BAYABASAN STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG PAGKAKAISA NG MAGKAKAPITBAHAY NG BAYABASAN-GENOVEVA HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO SP-56, S-92, AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED :

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT (BP BLG. 220) with Fifteen (15) lots, Community Mortgage Program, containing an area of Six Hundred Square meters and Twenty square decimeters (600.20 sq. m.), covered by Transfer Certificates of Title Numbered 82491, 82492 & 82493, of the Registry of Deeds of Quezon City, registered in the names of Matilde T. Reyes, Aurora T. Chong and Rodrigo Q.
