## ORDINANCE NO. SP- 916 3 S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH THIRTY-FIVE (35) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND THREE HUNDRED THREE SQUARE METERS AND TWENTY-TWO SQUARE DECIMETERS (1,303.22 SQ. M.), COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-121479 AND RT-2096 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 15-F (LRC) PSD-333900 AND LOT 14, PCS-787, DON PRIMITIVO STREET, BARANGAY OLD BALARA, QUEZON CITY, METRO MANILA, AS APPLIED BAGONG PAG-ASA NG LAURA HOMEOWNERS THE ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT (BP BLG. 220) with thirty-five (35) lots, Community Mortgage Program, containing an area of One Thousand Three Hundred Three square meters and Twenty-Two square decimeters (1,303.22 sq. m.), covered by Transfer Certificates of Title Numbered RT-121479 and RT-2096 of the Registry of Deeds of Quezon City, and located at Lot 15-F (LRC) Psd-333900 and Lot 14, Pcs-787, Don Primitivo Street, Barangay Old Balara, Quezon City, Metro Manila, as applied for by the BAGONG PAG-ASA NG LAURA HOMEOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No SP-56, S-93 and Batas Pamabansa Blg. 220, details of which are as follows:
