AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH ONE HUNDRED FIFTEEN (115) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF NINE THOUSAND NINE HUNDRED SEVENTY-TWO (9,972) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 116098, 149553, 46558, 165365 AND 49909 OF THE REGISTRY OF DEEDS OF QUEZON CITY AND LOCATED AT VIRGINIA ST. AND DR. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1.
