## ORDINANCE NO. SP- 934 4S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH TWENTY (20) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF EIGHT HUNDRED THIRTEEN SQUARE METERS (813 SQ. M.), COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-97199 AND RT-85656 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOTS 25 & 26, FLS-2592-D, DR. VILLAREAL ST., BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE VILLAREAL DULO URBAN POOR HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT (BP BLG. 220) with twenty (20) lots, Community Mortgage Program, containing an area of Eight Hundred Thirteen square meters (813 sq. m.), covered by Transfer Certificates of Title Numbered RT-97199 and RT-85656 of the Registry of Deeds of Quezon City, and located at Lots 25 & 26, Fls-2592-D, Dr. Villareal St., Barangay Gulod, Novaliches, Quezon City, Metro Manila, as applied for by the VILLAREAL DULO URBAN POOR HOMEOWNERS ASSOCIATION, INC., is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
